Sub: PETITION - for Panchayat Services, Electricity & Roads Repairs  
Ref: Anugraha Satellite Township Layout Approval by DTCP

1. The Anugraha Satellite Township Residents Welfare Association represents the civil society of house owners, residents and other stakeholders of Anugraha Satellite Township (township, for brevity) and their interests. The Association is also the custodian of the common areas and amenities of the township and is mandated to work towards the welfare of its residents. We are an elected body and it is our Honour to petition you for the following:
2. The Township layout has been approved by the Directorate of Town and Country Planning (DTCP) vide its order No 390/2017 dated 02-04-2019. The township has no Panchayat services extended to it since its inception in 2008.
3. The Township has implemented a Sewage Treatment Plant (STP) for the township out of our own funds. The electricity connection (Consumer No 020010131024) is in the name of the Special Officer, Mathalapattu Panchayat. The bi-monthly bill is being paid by the Township out of funds collected from a majority of houseowners and residents.
4. The TNEB has demanded a security deposit for the connection which we are unfortunately unable to pay due to paucity of funds. We pray that the STP's electricity connection be exempted from security deposit just like every other panchayat civic amenities connections.
5. The roads of the Township were laid around 10 years ago, handed over to the Panchayat and is in very bad shape. The ongoing monsoon has made it impossible for the township's residents, particularly our children and elderly from using the road. We humbly request that the roads be repaired in the short term and plans to re-lay the roads initiated at the earliest.
6. About 300 houses of the Township have obtained individual plot approval from DTCP/BDO office. Panchayat House Tax has not yet been levied. Assessment has to be done, tax demands raised, levied and collected. This is our kind request.
7. We request you to kindly allocate space for a solid waste segregation yard, composting area, and aggregation site to handle and dispose of the township's solid waste according to statutory norms.
